The County of Los Angeles provides transportation to and from the Junior Lifeguard Program from a number of pick-up locations in South and East Los Angeles. The transportation service is provided for families living a significant distance from the beach to enrich children's lives with summer time beach activities.

Transportation to and from our designated locations is available to participants enrolled in the Junior Lifeguard Program. **Seat space is limited and will be assigned on a first-come, first-serve basis. Program beaches and pick-up locations are subject to change or cancellation depending on enrollment.** Please mail the attached application to:

Parents are responsible for transporting participants to and from the pick-up locations. **Participants must be on time and the van pool/bus must leave on time.** Please send a parent note with the Junior Lifeguard for the bus supervisor if the participant will not be riding to and from their assigned session to their normal pick up/drop off location.

## **SAFETY and BEHAVIOR RULES**

1. Junior Lifeguards must be in uniform before getting in the bus or van.
2. Junior Lifeguards must obey the instructions of the bus driver, van driver and/or bus supervisor at all times.
3. Junior Lifeguards **must remain completely within the vehicle at all times** (no arms/legs out the windows). No item (trash, food, drinks, clothing, etc.) is to be held, thrown or dropped out of the bus/van windows. No item is to be thrown or poured inside the bus.
4. Junior Lifeguards must sit in designated seats and must remain seated at all times while the bus/van is in motion. Seat belts must be worn when riding in any of the vans or L.A. County vehicles.
5. All personal belongings and trash must be picked up before exiting the bus/van. (The Junior Lifeguard Program is not responsible for participant's personal belongings. It is highly recommended that participants do not bring anything of value: ipods, gameboys, etc.)
6. Any Junior Lifeguard's behavior deemed unacceptable by the bus/van drivers, instructors or staff may result in the participant being suspended or removed from the transportation program for the remaining session. Unacceptable behavior includes any violation of the Junior Lifeguard code of conduct or the refusal to follow bus supervisor's instructions.
