NOTICE OF SAFETY RISK

Notice to applicants taking the **1000 Meter Ocean Practice Swim**: this is not a part of the Ocean Lifeguard Candidate examination. This is not an offer of employment.

Although precautions have been taken to ensure your safety during this practice swim, certain risks are inherent, which cannot be completely eliminated. Such risks include, but are not limited, to the following:

Abrasions	Eye Injuries	Lacerations

Cramps	Hypoxia	Strains
